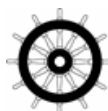

Product description

Free-fall Lifeboat Release Mechanism, with;

- Safe Working Load, SWL = 7.0 Tonnes

Application/Limitation

- Grades of materials as stated on drawings are to be delivered with makers product certificates (3.1).
- The various components transferring the load like wires, shackles, hooks, etc. are to comply with international standards or codes and are to be delivered with manufacturer's certificate, confirming a safety factor minimum 6 compared to the sustained load.
- Installation, onboard testing (MSC.81(70) part.2), support to the deck structure, and connection to power supply are not included in this examination and shall be accepted by attending surveyor in each case.
- Support to hull structure is not included in this examination and shall be evaluated separately.
