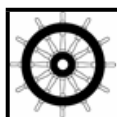

"class B-15 panels" consisting of 50 mm mineral wool Conrock 15 (density: 150 kg/m³) covered with galvanized steel steets, jointed with drilling screws, according to drawing nos.: BE 9 00 32 000 to BE9 00 32 005, attachments A.00 to A.05.

Application/Limitation

Approved for use as a horizontal fire retarding division of class B-15.

Maximum panel size: 800 x 3000 mm
