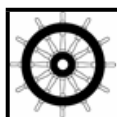

Product description

Panels consisting of 25 mm mineral wool Conrock 15 (density: 150 kg/m³) covered with 0.5 mm galvanized steel sheet on exposed side and 0.4 mm galvanized steel sheet on unexposed side, jointed with groove and tongue, screwed, according to attachment 1, 2 and 6; one panel has been perforated according to attachment 3; one panel has been fitted with a cable channel according to attachment 5.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Max panel size: 600 x 2465 mm (width x length).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
