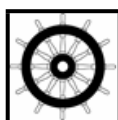

"DK032 RFTAPE"

Consist of a glass fiber cloth (0.32 mm) with density 318 g/m³ and adhesive (0.1 mm).

Total thickness 0.42 mm.

Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Products can be applied to any non-combustible substrate.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be MED certified.

Maximum gross calorific value shall be documented separately where applicable, ref. SOLAS Chapter II-2 Reg. 5.3.2.

Each product is to be supplied with its manual for installation and use.
