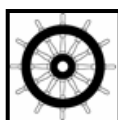

1st layer: Sigmaprime 200 (manufactured by Sigma Coatings), weight 75 g/m², thickness 0.04 mm
2nd layer: Herculan PSL Deco IMO F, weight 2800g/m², layer thickness 1.18 mm

Total coating thickness approximately 1.2 mm, total weight approximately 1875 g/m².

Application/Limitation

Primary deck covering, not generating excessive quantities of smoke nor toxic products in a fire.

The product may be applied over any steel or non-combustible material.

Not to be used as an integrated part of horizontal class A division, unless tested as such.

The product may also be used as floor covering in accordance with IMO 2010 FTP code part 5 appendix 4 paragraph 4.9.2.
