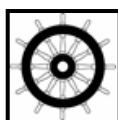

Product description

"A-60 Bulkhead with Rockfibras PNR-128 insulation"

composed of stiffened steel bulkhead insulated with Rockfibras PNR-128 with nominal density of 128 kg/m³ and thickness of 2 x 40 mm on steel sheet and 30 mm x 145 mm above the stiffeners.

The insulation to be fixed by Ø3 mm steel pins with max. spacing: 150 mm horizontal, 400 mm vertical (300 mm on stiffeners) and approx. 250 mm diagonal.

Application/Limitation

Approved for use as a vertical fire retarding division of class A-60.
