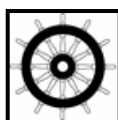

Quilted mattress consisting of ticking -100% cotton to an 8 mm fire retardant foam with density of 36 kg/m³, manufactured by Dunlop Foams. The inner support consist of 25 mm fire retardant foam, as above, on each side of the spring system.

Total thickness approximately 170 mm.
