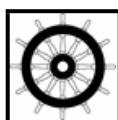

- 0.02 mm Tefrotex SF bonding coat

Application/Limitation

Primary deck covering, not generating excessive quantities of smoke nor toxic products in a fire.

The product may also be used as floor covering in accordance with IMO 2010 FTP Code Part 5 appendix 4 § 4.9.2.

The product may be applied over any steel or non-combustible material.

Maximum organic content: 3 %

Not to be used as an integrated part of horizontal class A division, unless tested as such.
