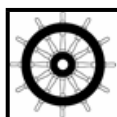

Product description

"AL-30150 type ABM rock wool covering"

AL-30150 type ABM rock wool covering is an aluminum laminate facing foil of 15µm nominal thickness combined with 5x5 square glassfiber fabric through PE hot-melt adhesive (max. applied weight: 30g/m²), Manufactured by Shanghai ABM Rock Wool Dafeng Co.; Ltd.

Substrate:

Rock wool board 50mm thick (density 50kg/m³)

Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as decorative veneer on non-combustible substrate of density 37.5 kg/m³ or more and thickness of 50mm or more.

The product satisfies the requirement for maximum calorific value (ref. Solas Chapter II-2, Reg 5.3.2.2) without further testing.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Each product is to be supplied with its manual for installation, use and maintenance.
