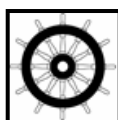

Product description

"weberfloor 4680N Marine Light"

a polymer modified cement based fine smoothing compound for use as a levelling layer for primarily steel, galvanized steel and aluminium decks. It is supplied as a light weight one-component dry powder for hand application at layer thicknesses between 0-20 mm.

The areal density is 0.9 kg/m² per mm thickness of layer.

Application/Limitation

Primary deck covering, not generating excessive quantities of smoke nor toxic products in fire.

Not to be used as an integrated part of horizontal class A division unless tested as such.
