Product description

"SW-506HNR B-15 Class Bulkhead"

is a bulkhead panel, in central part, composed of two layers each of a 21.5 mm thick "Mineral Wool 140" core with nominal density of 140 kg/m³ (manufactured by KCC CORPORATION), 0.4 mm perforated corrugate steel sheet in between and 0.4 mm perforated steel sheets from both sides. Panel is closed with 0.55 mm galvanized steel M-profile, bonded by means of adhesive with 50 mm thick and 50 mm long "Mineral Wool 240" with nominal density of 240 kg/m³ (manufactured by KCC CORPORATION), from both ends. Panel is covered from both sides with 0.55 mm galvanized steel sheet bonded by means of adhesive.

Panels are joined by means of spline joints at M-profile faces, made from a 3 mm thick galvanized steel.

Total panel thickness: 50 mm

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Max. panel size: 620 x 2480 mm (W x H)
