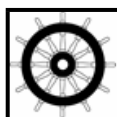

"Axminster Carpet"

Is a decorative carpet consisting of yarn material 80% wool and 20% nylon and backing material of jute and Polyester tested on a 3 mm thick steel plate.

Pile height: 8 mm
Total pile weight: 1836 g/m²
Overall thickness: 10 mm
Nominal carpet weight: 3226 g/m²
Max. organic content: 70 %

Max amount Density: 320 Kg/m³

Carpet colour: 84.81% dark green primary colour, 7.41% light green and 7.78% yellow).

Adhesive:

PAPU-O3 type two-component polyurethane adhesive produced by Jingjiang Asian pacific Special Material Co.; Ltd. (Density :200g/m²)

Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as floor covering on any low flame-spread floor covering, steel or non-combustible material.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Each product is to be supplied with its manual for installation, use and maintenance.
