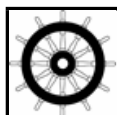

"JCP-DF2 Type Class A-60 Floating Floor"

composed of a structural steel deck insulated on top with compound rock wool panels. The compound rock wool panels consist of (from the bottom) 50 mm thick rockwool with density of 120 kg/m³ (manufactured by Jiangyin Anzhou Construction Material Co.,Ltd.) and 2.5mm thick steel plate.

Total thickness: 52.5 mm.

Application/Limitation

Approved for use as a horizontal fire retarding division of class A-60.
