Product description

"A60 Class Deck - DAEHYUP Spray S-D101(AL)"

is an aluminium deck that is spray insulated on stiffened side with a continuous layer of insulation type "DAEHYUP SPRAY S" with nominal density of 140 kg/m³ (produced by Daehyup Spray Co., Ltd.). The insulation layer is covering the bulkhead plate between the stiffeners (min. 50 mm thick) as well as all the sides (min. 30 mm thick) and inside of the stiffeners.

Application/Limitation

Approved for use as a horizontal fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.
