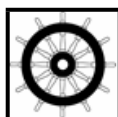

"WJ F60-VI Type Class A-60 Light Compound Deck"

composed of structural steel deck insulated on top with different layers from bottom to top as follow:

- layer of "WJ-2 Perlite Cement Covering", 30 mm thick with nominal density of 675 kg/m³
- layer of glass fiber fabric
- layer of "WJ F60-VI Light Compound Fire Deck Covering", 10 mm thick with nominal density of 1000 kg/m³

Total thickness: 40 mm
