Product description

"SW-M250 B-0 Class Bulkhead"

is a bulkhead panel composed of one layer of a 25 mm thick mineral wool core with nominal density of 140 kg/m³ (manufactured by BYUCKSAN CO.) and 0.55 mm galvanized steel sheets from both sides bonded by means of adhesive.

Panels are joined by means of c-clip joint profiles made from 0.55 mm thick galvanized steel.

Total panel thickness: 25 mm

Approved for use as a vertical fire retarding division of class B-0.

Max. panel size: 600 x 2480 mm (W x H)
