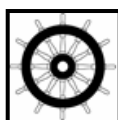

"A-60-B-IV"

a structural steel bulkhead insulated on stiffeners side and upon stiffeners with min. 20 + 20 mm ceramic fibre blanket Type TG-2 (manufactured by Changzhou Thermal Insulation Material Factory Co., Ltd) with density 170 kg/m³). The insulation is fixed with steel pins and washers (18.9 sets/m²).

Application/Limitation

Approved for use as a vertical fire retarding division of class A-60.

General application: fire against either side.
