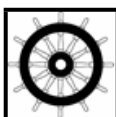

A U.S. Coast Guard approval number will be assigned to the equipment when the production module has been completed and will appear on the production module certificate (module D, E or F), as allowed by the "Agreement between the European Community and the United States of America on Mutual Recognition of Certificates of Conformity for Marine Equipment", signed February 27th, 2004.

The mark of conformity may only be affixed to the above type approved equipment and a Manufacturer's Declaration of Conformity issued when the production-surveillance module (D, E or F) of Annex B of the MED is fully complied with and controlled by a written inspection agreement with a Notified Body. The product liability rests with the manufacturer or his representative in accordance with Directive 2014/90/EU.

Product description

"Marine HMT-170 type A-60 Bulkhead"

is a Class A-60 bulkhead consisting of a 5mm steel plate suitable stiffened, insulated on the plate surface with two layers of 20mm ceramic wool plate and two layers of 15mm ceramic wool plate around the stiffeners, acc. to figure 1 and 2, page 6 and 8 of the test report.

The steel plate was insulated on the exposed side with two layer of HMT-170 ceramic wool plate (Density: 170Kg/m³) manufactured by Tianjin Haimen building material Co.; Ltd.

Fixing the insulation to the steel deck was done by welded pins (20 sets/m²) with ø 3 mm and with ø 30 mm steel washers on top . No adhesive was used in this construction.

Application/Limitation

Approved for use as a fire retarding bulkhead of class A-60.

General application: Fire hazard from either side.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
