Product description

"SW-M506 (B-15 Class bulkhead)"

panel composed of 50 mm thick mineral wool insulation, manufactured by Byucksan Co. with nominal density of 140 kg/m³ and glued to 0.55 mm thick galvanized steel sheets on both sides. Panels are joined together by 0.55 mm thick galvanized steel joint profiles on both sides.

The panels may be fitted with 25 mm deep, 100 mm wide and 1500 mm long cable conduit on unexposed side, made of 0.55 mm thick galvanized steel.

Total panel thickness: 50 mm

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Maximum panel size: 600 x 2480 mm (W x H)
