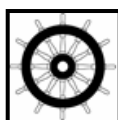

A U.S. Coast Guard approval number will be assigned to the equipment when the production module has been completed and will appear on the production module certificate (module D, E or F), as allowed by the "Agreement between the United States of America and the EEA EFTA states on the mutual recognition of Certificates of Conformity for Marine Equipment" signed 17 October 2005.

The mark of conformity may only be affixed to the above type approved equipment and a Manufacturer's Declaration of Conformity issued when the production-surveillance module (D, E or F) of Annex B of the MED is fully complied with and controlled by a written inspection agreement with a Notified Body. The product liability rests with the manufacturer or his representative in accordance with Directive 2014/90/EU.

This certificate is valid for equipment, which is conform to the approved type. The manufacturer shall inform DNV GL AS of any changes to the approved equipment. This certificate remains valid unless suspended, withdrawn, recalled or cancelled.

Should the specified regulations or standards be amended during the validity of this certificate, the product is to be re-approved before being placed on board a vessel to which the amended regulations or standards apply.



## Product description

"SC-AH-B0 (B-0 Class Ceiling Access Hatch)"

is a single leaf hatch composed of an insulating core of 25mm thick rock wool with density 60 kg/m<sup>3</sup> (manufactured by Byucksan Co. Ltd.) faced from exposed side by 0.6 mm thick galvanized steel plate. Hatch leaf equipped with two push buttons and is fixed to hatch frame by means of piano hinge. The Z-type hatch frame is composed of 1.2 mm thick galvanized steel profile and fixed to ceiling panels by means of 8 screws/pop rivets. Hatch leaf is opening towards exposed side.

Total hatch leaf thickness is 25 mm.

## Application/Limitation

Approved for use as an integrated part of a horizontal fire retarding division of class B-0.

Approved for installation in the tested ceiling type SC-253 from TNF Inexa Korea Co. Ltd. Installation in other ceilings may be approved case-by-case. Ceiling has to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Maximum size of hatch leaf: 525 x 525 (W x L).

Maximum clear opening: 495 x 495 (W x L).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
