Product description

"SW-506 (B-15 Class Bulkhead)"

is a bulkhead panel composed of insulation core of 50 mm thick mineral wool of density 140 kg/m³ (manufactured by Byucksan Co. Ltd.) bonded from both sides with 0.55 mm thick galvanized steel sheet by means of adhesive. Side edges on the panel are fitted with 0.55 mm thick steel M-profile.

Adjacent panels are joined together by means of spline joint (3 x 30 mm).

Total thickness of panel: 50 mm

For further details, see documentation mentioned under Type Examination documentation below.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Maximum size of panel: 620 x 2480 mm (W x H).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
