Product description

"C-406 (B-15 Class Ceiling Panel)"

ceiling panels composed of mineral wool, manufactured by Byucksan Co.Ltd. with nominal density of 200 kg/m³, and with 0,55 mm thick galvanized steel sheets on both sides. The steel sheets are glued to the mineral wool with an adhesive.

Total panel thickness is 40 mm.

Panels are to be jointed together with screwed H- profiles as shown on drawing mentioned under Type Examination documentation below.

Application/Limitation

Approved for use as a horizontal fire retarding division of class B-15.

Max. panel size (L x W): 3000 mm x 620 mm. (No panel joints in L- direction)

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.
