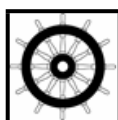

Product description

"Non-woven fabric"

composed on the exposed side of a 0.6 mm perforated steel sheet (Ø1.8 mm), adhesive, 0.37 mm non-woven fabric and 40 mm thick mineral wool of density 80 kg/m³ (manufactured by KCC Corporation, Korea).

Total thickness 41 mm.

Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as decorative veneers on non-combustible substrate with a thickness greater than 10 mm.

Approved colour: Black and brighter colours
Max. organic content: 0 %

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

The product satisfies the requirement for maximum calorific value (ref. Solas Chapter II-2, Reg 5.3.2.2) without further testing.
