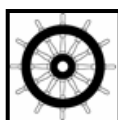

- Fast rescue boat equipment and marking/instructions to be inspected after installation onboard the ship. Equipment shall comply with LSA Code and IMO Res. MSC.81(70).
- The fast rescue boat is fitted with a release hook without on-load release capabilities, in accordance with LSA Code 4.4.7.6.17. Hence, if it is to be combined with launching appliances with permanent high speed tensioning device (LSA Code 6.1.7.3), compatibility must be assured.
- The normal equipment of the fast rescue boat to include a hands-free and watertight VHF radiocommunication set, in addition to the ones required on the bridge.
- The design assessment is based on IMO Res. MSC.48(66) as amended by IMO Res. MSC.207(81), IMO Res. MSC.218(82), IMO Res. MSC.272(85) and IMO Res. MSC.320(89).
- Production and installation testing shall be carried out according to IMO Res. MSC.81(70) as amended, Part 2.
