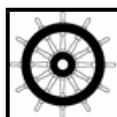

A U.S. Coast Guard approval number will be assigned to the equipment when the production module has been completed and will appear on the production module certificate (module D, E or F), as allowed by the "Agreement between the European Community and the United States of America on Mutual Recognition of Certificates of Conformity for Marine Equipment", signed February 27th, 2004.

The mark of conformity may only be affixed to the above type approved equipment and a Manufacturer's Declaration of Conformity issued when the production-surveillance module (D, E or F) of Annex B of the MED is fully complied with and controlled by a written inspection agreement with a Notified Body. The product liability rests with the manufacturer or his representative in accordance with Directive 2014/90/EU.

This certificate is valid for equipment, which is conform to the approved type. The manufacturer shall inform DNV GL SE of any changes to the approved equipment. This certificate remains valid unless suspended, withdrawn, recalled or cancelled.

Should the specified regulations or standards be amended during the validity of this certificate, the product is to be re-approved before being placed on board a vessel to which the amended regulations or standards apply.



Product description

"HMTD-96 Type Class A-60 Fire Deck"

composed of stiffened steel deck insulated with one layer of 30 mm thick type "HMT-96" ceramic wool with density of 96 kg/m³ (manufactured by Tianjin Haimen Building Material Co., Ltd.) between and around the stiffeners. The insulation is fixed on the unexposed side by ø3 mm steel pins with ø30 mm washers.

Pins between stiffeners are positioned in square pattern in such manner that the maximum distance between pins is 300 mm perpendicularly to stiffeners and 250 mm longitudinally. Maximum distance between insulation panels joint and pins is 60 mm.

Application/Limitation

Approved for use as a horizontal fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
