Product description

"B50C Bulkhead Panel"

composed of a 48.9 mm thick insulation layer, density 120 kg/m³, by Rockwool Firesafe insulation Co., Ltd. covered with 0.55 mm thick galvanized steel sheets on both sides. The insulation is glued to the steel sheets by an adhesive.

The panels are joined together by spiral formed steel clips.

Total bulkhead panel thickness is 50 mm.

For further details, see drawings stated under Type Examination documentation below.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Maximum panel size: 650 x 2970 mm (W x H).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
