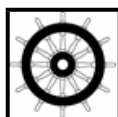

A U.S. Coast Guard approval number will be assigned to the equipment when the production module has been completed and will appear on the production module certificate (module D, E or F), as allowed by the "Agreement between the European Community and the United States of America on Mutual Recognition of Certificates of Conformity for Marine Equipment", signed February 27th, 2004.

The mark of conformity may only be affixed to the above type approved equipment and a Manufacturer's Declaration of Conformity issued when the production-surveillance module (D, E or F) of Annex B of the MED is fully complied with and controlled by a written inspection agreement with a Notified Body. The product liability rests with the manufacturer or his representative in accordance with Directive 2014/90/EU.

This certificate is valid for equipment, which is conform to the approved type. The manufacturer shall inform DNV GL SE of any changes to the approved equipment. This certificate remains valid unless suspended, withdrawn, recalled or cancelled.

Product description

"DKY-3 Type Class A-60 Light Floating Fireproof Deck Covering"

Constructed on a 5 mm suitable stiffened steel deck; insulated from bottom to top with one 20 mm thick layer of ceramic wool, steel mesh and a 30 mm thick non-combustible material of DKY-3, type Light Floating Deck Covering.

Insulation material:

- TG-2 type ceramic wool manufactured by Changzhou City Insulation Material Factory, (density: 170 kg/m³)
- DKY-3, type Light Floating Deck Covering manufactured by Jingjiang Dakeyuan New Material Engineering Co., Ltd. (density: 1500 kg/m³)

Totally thickness of floating floor is 50mm.

Application/Limitation

Approved for use as a horizontal fire retarding divisions of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.
