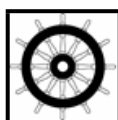

A U.S. Coast Guard approval number will be assigned to the equipment when the production module has been completed and will appear on the production module certificate (module D, E or F), as allowed by the "Agreement between the United States of America and the EEA EFTA states on the mutual recognition of Certificates of Conformity for Marine Equipment" signed 17 October 2005.

The mark of conformity may only be affixed to the above type approved equipment and a Manufacturer's Declaration of Conformity issued when the production-surveillance module (D, E or F) of Annex B of the MED is fully complied with and controlled by a written inspection agreement with a Notified Body. The product liability rests with the manufacturer or his representative in accordance with Directive 2014/90/EU.

consisting of Heterogeneous polyvinyl chloride luxury vinyl tiles glued to the surface with adhesive type FBall F46.

Weight per unit area: 4100 g/m²
Max thickness: 2.5 mm

Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved colour: flamingo (dark brown)
Max. organic content: 54 %

Approved for use over any low flame-spread floor covering, steel or non-combustible material.

Several layers of floor coverings are acceptable provided that each layer is approved according to the Marine Equipment Directive and bear the mark of Conformity.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Each product is to be supplied with its manual for application and maintenance.
