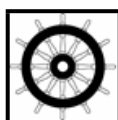

Paint system consisting of a two component, modified polyamide cured epoxy primer containing zinc phosphate (max. dry film thickness 100 µm).

Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as paint system on a metallic substrate with thickness of at least 3.75 mm.

Approved colour: Grey, Ivory etc.

Max. organic content: 50 wt% per dry film thickness
