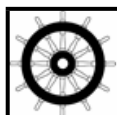

A U.S. Coast Guard approval number will be assigned to the equipment when the production module has been completed and will appear on the production module certificate (module D, E or F), as allowed by the "Agreement between the European Community and the United States of America on Mutual Recognition of Certificates of Conformity for Marine Equipment", signed February 27th, 2004.

The mark of conformity may only be affixed to the above type approved equipment and a Manufacturer's Declaration of Conformity issued when the production-surveillance module (D, E or F) of Annex B of the MED is fully complied with and controlled by a written inspection agreement with a Notified Body. The product liability rests with the manufacturer or his representative in accordance with Directive 2014/90/EU.

This certificate is valid for equipment, which is conform to the approved type. The manufacturer shall inform DNV GL SE of any changes to the approved equipment. This certificate remains valid unless suspended, withdrawn, recalled or cancelled.

Should the specified regulations or standards be amended during the validity of this certificate, the product is to be re-approved before being placed on board a vessel to which the amended regulations or standards apply.



Product description

"JCP-L2-L" and "JCP-L5-L" Type Class B-0 Bulkheads are composed of lining panels made of an aluminium honeycomb core covered on both sides with 0,5 mm thick steel sheets.

The honeycomb core (manufactured by Jiangsu Hailu) is of a hexagonal cellular shape with a depth of 24 mm, 13 mm long sides and with an aluminium foil thickness of 0,06 mm. Adhesive of approved type is used between the steel sheets and the aluminium honeycomb core.

Panel joints:

"JCP-L2-L": The panels are fastened to each other by means of clips.

"JCP-L5-L": The panels are fastened to each other by means of wedges, with 28 mm deep wedge cuts.

Total thickness of a panel is 25 mm.

Maximum dimensions of a panel is 600 x 2500 mm (width x height).

The construction of the "JCP-L2-L" type Class B-0 bulkhead shall be in accordance with the manufacturer's drawings Nos. HL-L2-L-03-T2, HL-L2-L-03-T2-01 and HL-L2-L-03-T2-02 which are included in the test report.

The construction of the "JCP-L5-L" type Class B-0 bulkhead shall be in accordance with the manufacturer's drawings Nos. HL-L5-L-03-T2, HL-L5-L-03-T2-01, HL-L5-L-03-T2-02 and HL-L5-L-03-T2-T3 which are included in the test report.

For further details see test report mentioned under "Type Examination documentation" below.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-0.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Maximum dimensions of a panel is 600 x 2500 mm (width x height).

This Certificate is replacing the previous MED-B 11359-14 HH issued on 2014-11-20.

Each product is to be supplied with its manual for installation, use and maintenance.
