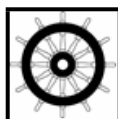

"Axminster Carpet"

is a machine-woven wall-to-wall carpet. The carpet consists of 80% wool and 20% nylon on a 2.0N/1 jute with 20s/6e polyester backing.

Pile height: 7 mm
Pile weight: 1570 g/m²
Total weight: 3000 g/m²
Maximum thickness: 10 mm

Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as floor coverings on a metallic substrate with thickness of at least 3 mm.

Approved color: Yellow, orange and red pied color.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

Each product is to be supplied with its manual for installation, use and maintenance.
