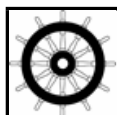

Product description

"B25CL Type Class B-0 Bulkhead"

Bulkhead panels composed of aluminum honeycomb (made of 0.04 mm thick aluminum foil with side length of 7.5 mm) covered with 0.6 mm galvanized steel plates on both sides.

Honeycomb and steel plates are glued together with adhesive of PAPU-03 type (manufactured by Jingjiang Green Functional Material Co., Ltd). The panels are connected to each other by means of connector clip fitted at the ends of each panel.

Total thickness of the panels is 25 mm.

For further details see drawing listed under Type Examination documentation below.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-0.

Max. panel size is 700 mm x 2970 mm (W x H).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
