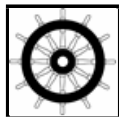

Product description

"T25AXY Type Class B-0 Continuous Ceiling"

Ceiling panels composed of 25 mm thick YG-2 type rock wool insulation with nominal density of 120 kg/m³ (produced by Changzhou Thermal Insulation Material Factory Co., Ltd.) covered on both sides by 0.6 mm thick galvanized steel sheets. The steel sheets are perforated with ø2.5 mm sound-absorbing holes in diagonal distance of c/c approx. 5 mm.

The panels are wedge joint (22 mm in depth), connected together by T-type beam, connected with the deck by hanger sets. The ceiling is suspended to the A class deck with 500mm air gap by hangers.

Total panel thickness: 25 mm

Approved for use as a horizontal fire retarding division of class B-0.

Maximum panel size: 550 x 2420 mm (W x L)

Maximum distance between hanger sets: 600 mm

Maximum distance between T-carriers: 2420 mm

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.
