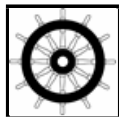

- polyester wet coating [Polyceram 310 mat interior (tested surface)], manufactured by Holland Coating Industries
- primer Polyceram 310 mat interior, manufactured by Holland Coating Industries
- 0.5 mm Aluminium sheet (EN AW 5050) manufactured by Hunter Douglas Europe BV.

Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

The product satisfies the requirement for maximum calorific value (ref. SOLAS Chapter II-2, Reg 5.3.2.2) without further testing.

Each product is to be supplied with its instructions for installation, use and maintenance.
