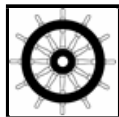

Product description

'Class A-15 Bulkhead - Basalt Rock Wool Board Wrapped'

Composed of a structural steel bulkhead insulated with a 30 mm thick LYBST Basalt Rock Wool Board (nominal density 45 kg/m³, manufactured by Luyang Energy-saving Materials Co., Ltd. with) between the stiffeners.

The Basalt Rock Wool Board is held in place using Ø3 mm steel copper coated pins with Ø30 mm steel washers which are welded to the bulkhead. The pins are installed with a nominal spacing of 300 mm (max. 350 mm). The pins at the joints of the boards shall have nominal spacing of 160 mm from the edge.

Application/Limitation

Approved for use as a vertical fire retarding division of class A-15.

General application: Fire hazard from either side.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.
