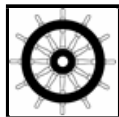

System composed of one coat of 50 µm thick one-component, waterborne acrylic zinc phosphate primer "PPG AQUACOVER 25" and one coat of 75 µm thick one-component, waterborne acrylic dispersion finish "PPG AQUACOVER 45 NF".

Max thickness: 125 µm (dry film thickness).

Application/Limitation

Approved for use as low flame spread material, not generating excessive quantities of neither smoke nor toxic products in fire.

Approved for use as paint systems on a metallic substrate with thickness of at least 3.75 mm.

PPG AQUACOVER 25:

Approved paint colour: off-white

Maximum organic content: 30 wt%

PPG AQUACOVER 45 NF:

Approved for all colour variations

Maximum organic content: 40 wt%
