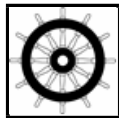

Product description

EDS 200,

is an electrical fire door control system. Main system components are electrical motor, generator, insulated junction box for control system (JB01), insulated junction box for motor card (JB02) and temperature sensor box.

The insulated junction boxes (JB01 and JB02) are constructed of an inner and outer steel skin and an insulated core (Rigidur H Marine with density 1200 kg/m³). Dimension of the boxes are 424 ± 5 mm x 178 ± 5 mm x 142 ± 2 mm (L x H x W).

Application/Limitation

Approved for use as a fire door control system for approved fire sliding doors.

The fire door control system has only been evaluated with respect to fire technical properties.

Maximum weight of door to be actuated by the control system: 800 kg.

The fire door control system is to be installed and tested in accordance with SOLAS II-2/9.4.1.1.4 or HSC Code 7.9.3.3.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
