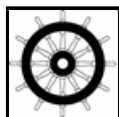

Product description

"TNF-C46 B-15 Class Ceiling Panel"

composed of ceiling panels mounted with a 420 mm air gap to the structural steel deck. The ceiling panels consist of 69.5 mm thick ROCKWOOL of 80 kg/m³ density, manufactured by Weihai Bosheng Advanced Materials Co., Ltd., covered on the underside with a 0.56 mm thick galvanized steel sheet. No glue is used. The ceiling panels are joined by means of carriers (horizontally) and cross carriers (vertically) and suspended by means of hangers.

Total thickness of the panel is 70 mm.

For further details see drawings mentioned under Type Examination documentation below.

Application/Limitation

Approved for use as a horizontal fire retarding division of class B-15.

Maximum panel size is 600 mm x 600 mm (W x L).

Maximum distance between hangers is 600 mm.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, and maintenance.
