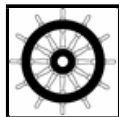

Product description

“ArmaFix”

The insulation cover is composed of the following three (3) layers:

1. An upper layer: 0.8 mm thick aluminium plate (colour: Alu, density 2.7 g/cm³)
2. An intermediate layer: ArmaFlex 520 glue (colour: light yellow, density 0.8 g/cm³)
3. A lower layer: 9 - 40 mm thick PU (colour: yellow, density 160 kg/m³)

Nominal total thickness: 9 - 40.8 mm.

Max. organic content: 70%.

Application/Limitation

Approved for use as combustible insulation material with low flame-spread characteristics, not generating excessive quantities of smoke nor toxic products in fire.

The product may be used on cold service pipework / fittings for refrigeration system everywhere onboard, and for pipework, fittings, air ducts and tanks insulation in cargo areas, mail rooms, baggage rooms and refrigerated compartments of service spaces, and exterior locations (SOLAS II-2/5 3.1.1).

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the MED Mark of Conformity.

Extent of application is to be considered and accepted for each case/project.

Each product is to be supplied with its manual for installation and maintenance.
