Product description

"BOLIDECK A60 Si (Ultimate)"

An insulated deck composed of a stiffened steel deck insulated on the upper side of the structural core.

The insulation consists of three 25 mm thick layers of mineral wool ISOVER ULTIMATE U MPN 90 (density 90 kg/m³, manufactured by SAINT-GOBAIN ISOVER G+H AG). Between 2nd and 3rd layer of mineral wool there is one layer of thin glass fibre reinforced aluminium foil.

The mineral wool boards are placed with overlap joints.

For further details see approved test report listed under Type Examination documentation below.

Application/Limitation

Approved for use as a horizontal fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
