Product description

"FTG 50 PANEL - PB1503",
is composed of panels made of 0.5 mm thick galvanized steel sheets insulated with one layer of 48 mm thick mineral wool of type "PBE BOARD M16" (density 120 kg/m³, manufactured by KNAUF INSULATION d.o.o.). The insulation layer is fixed to the galvanized steel sheets by means of adhesive.

The joints of the panels are of the type tongue-and-groove.

Total panel thickness is 50 mm.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Max. panel size: 3000 x 560 mm (H x W).

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
