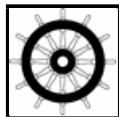

Product description

"B-15 Class Window SG-FS2R1P-B15"

The window unit is a 20 mm thick fire resistant glass from Samgong (model FS2R1-B15) composed of 8 mm toughened glass, 7 mm intumescent interlayer and 5 mm toughened glass.

The window frame is composed of a 4.5 mm thick main steel frame screwed (M6, max. c/c 120 mm) to a 4.5 mm thick glass keeper of mild steel, welded to 12 mm thick glass stopper of mild steel on the opposite side, 5 mm thick window supporter and 3 mm thick window adjuster, keeping the window unit in position.

The 1.2 mm thick window boxes, sealed by sealant (Kiilto Masa), are insulated by FireMaster Marine Plus Blanket (density 128 kg/m³) manufactured by Thermal Ceramics UK Ltd.

The window assembly also includes setting blocks (made from hardboard) and sealing (Kiilto Masa) between the window unit and window frame.

Application/Limitation

The window is approved for installation in steel bulkheads of class B-15. Other applications are subject to case-by-case approval.

Restricted application: Fire against 5 mm tempered glass.

Maximum size of window: 2140 x 1640 mm (W x H).

Maximum size of clear opening: 2000 x 1500 mm (W x H).

The window has only been evaluated with respect to fire technical properties (e.g., strength requirements have not been considered). Arrangement and location of any window is subject to approval from relevant authorities in each case.

Each product is to be supplied with its manual for installation and use.
