Product description

"GLAVA LAMELLMATTE"

is a glass wool mat with cross-woven fibres fixed to a glass fibre reinforced aluminium foil on one side. The aluminium foil is applied to the glass wool mat by means of an adhesive.

Total (maximum) thickness:	100 mm
Nominal density of glass wool mat (approx):	28 kg/m ³
Nominal organic content of glass wool mat (approx):	8.2 %
Thickness of aluminium foil:	18 µm
Weight of aluminium foil per unit area:	95±10 g/m ²
Weight of adhesive per unit area:	28±5 g/m ²

Application/Limitation

Approved for use as low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code Part 5 and to be approved according to the Marine Equipment Directive and bear the Mark of Conformity.

The product satisfies the requirement for maximum calorific value (ref. SOLAS Chapter II-2, Reg 5.3.2.2) without further testing.

Approved for use as decorative veneer on any non-combustible substrate.

Each product is to be supplied with its manual for installation and use.
