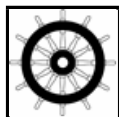

## Product description

Rescue boat Winch with:

- Maximum Working Load, MWL = 1.6 tonnes (3 layers)
- Maximum Hoisting Load, MHL = 1.6 tonnes
- Wire Rope Diameter = 12 mm

## Application/Limitation

- Grades of materials as stated on drawings are to be delivered with makers product certificates (3.1).
- The various components transferring the load like wires, shackles, hooks, etc. are to comply with international standards or codes and are to be delivered with manufacturer's certificate, confirming a safety factor minimum 6 compared to the sustained load.
- Falls to be used with the launching appliance shall be of rotation-resistant and corrosion resistant steel wire rope.
- Installation, onboard testing (MSC.81(70) part.2), support to the deck structure, and connection to power supply are not included in this examination and shall be accepted by attending surveyor in each case.
