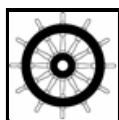

Primary deck covering, not generating excessive quantities of smoke nor toxic products in fire.

Approved colour: grey

Maximum organic content: 63 wt%

The product may also be used as floor covering in accordance with IMO 2010 FTP Code Part 5 appendix 4 paragraph 4.9.2.

The product may be applied over any steel or non-combustible material.

Not to be used as an integrated part of horizontal class A division unless tested as such.

The product may also be used as floor covering and fulfils the requirement for surface materials for bulkheads, walls, ceilings and panels.

Each product is to be supplied with its manual for installation and maintenance.
