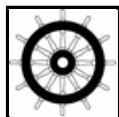

"SIGMAPRIME 700 @ 200 micron + SIGMACOVER 456 @ 110 micron", system composed of one coat of two-component, epoxy anticorrosive primer SIGMAPRIME 700 (dry film thickness 200 µm) and one coat of two-component high-build polyamide-cured epoxy coating SIGMACOVER 456 (dry film thickness 110 µm).

Maximum thickness: 310 µm (dry film thickness)

Application/Limitation

Approved for use as low flame spread material, not generating excessive quantities of neither smoke nor toxic products in fire.

Approved for use as paint systems on a metallic substrate with thickness of at least 3.75 mm.

Approved paint colour: grey, redbrown, yellow/green, green, and eggshell

Maximum organic content (dry film): 45 wt%

SIGMACOVER 456:

Approved for all colour variations.
