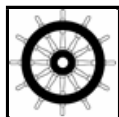

## Product description

"BSSF-90K40/25T",

composed of a structural steel bulkhead insulated on exposed side with a single layer of 40 mm thick BSS type marine rock wool board (density 90 kg/m<sup>3</sup>, manufactured by Weihai Bosheng Advanced Materials) applied between stiffeners and 25 mm thick BSS type marine rock wool board (density 90 kg/m<sup>3</sup>, manufactured by Weihai Bosheng Advanced Materials) around stiffeners. Stiffener cavities are filled with insulation.

The blankets are held in place using steel pins (Ø 3 mm) welded to the bulkhead and 30 mm washers. The pins are to be installed with an average spacing of 300 mm across the blankets and on average 300 mm along the blankets, whereas pins at the joints between blankets shall have a nominal spacing of 150 mm from the blanket edge.

## Application/Limitation

Approved for use as a vertical fire retarding division of class A-60.

Restricted application: Fire from insulated side only.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
