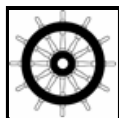

Product description

“CLP-L3A Type Class B-15 Marine Lining”

Is the lining panels composed of an 23.5 mm thick insulation core, KMD-Y type marine rock wool (density of 120 kg/m³, produced by Tianchang KMD New Insulation Materials Co., Ltd.) covered from both sides with 0.6 mm thick galvanized steel plate.

Insulation is glued to the steel plates by means of polyurethane adhesive.

The plates are connected using wedge joints, with 22 mm deep wedge cut.

Total panel thickness: 25 mm.

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Maximum panel size: 2980 mm x 600 mm (H x W)

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.
