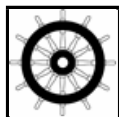

Product description

"SW-506HN (B-15 Class Bulkhead)"

Is the bulkhead composed of one layer of 49 mm thick mineral wool, placed on each side of the panel edges, with density 240 kg/m³ and two layers of 21.5 mm thick each mineral wool with density 140 kg/m³, placed in the panel centre, separated with 6 mm air gap incorporating a 0.6 mm thick perforated corrugated steel sheet. Both mineral wools are manufactured by KCC Corporation and covered from both sides with 0.55 mm galvanized steel plate.

Insulation is glued to the steel plates by means of polyurethane adhesive.

The plates are connected using 0.55 mm thick M-profile and 3 mm thick spline joint.

Total panel thickness: 50 mm

Application/Limitation

Approved for use as a vertical fire retarding division of class B-15.

Maximum panel size: 620 mm x 2480 mm (W x H/L)

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
