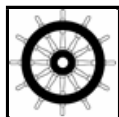

Product description

"BSSFB-80K25T-FR30"

is an A-30 class steel deck insulated with a single layer of 25 mm thick BSS type marine rock wool board (density 80 kg/m³, manufactured by Weihai Bosheng Advanced Materials Co., Ltd.) applied between stiffeners and 25 mm thick BSS type marine rock wool board (density 80 kg/m³, manufactured by Weihai Bosheng Advanced Materials Co., Ltd.) used around stiffeners. Stiffener cavities are filled with insulation.

The boards are held with steel pins (Ø 3 mm) and washers (Ø 30 mm). The spacing between pins along and across the boards is 300 mm on average.

For further details, see drawings listed under Type Examination documentation.

Application/Limitation

Approved for use as a horizontal fire retarding division of class A-30.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and maintenance.
